From the Director of Medical Education letter Ref. No. 064209/PME3/2023, dated 18.09.2024, 25.09.2024 and 27.09.2024.

ORDER:

While moving the demand of Health and Family Welfare Department for the year 2024-2025, the Hon'ble Minister for Health and Family Welfare had announced on the floor of the House that a "Certificate course for Home Based Elderly Care Support Assistant" will be started in Government Medical Colleges.

2. Based on the above announcement, the Director of Medical Education and Research has sent a proposal and requested to permit to start three months duration of "Certificate course for Home based Elderly Care Support Assistant" in all the Government Medical Colleges from the academic year 2024-2025.

3. The Government, after careful examination, have decided to accept the proposal of Director of Medical Education and Research and grant permission to start three months duration "Certificate course for Home based Elderly care Support Assistant" at all the Government Medical Colleges from the academic year 2024-2025 with an intake of 25 seats per college, except The National Institute of Ageing, Chennai which is permitted 100 seats, subject to the condition that there is no additional financial commitment to the Government and no new posts shall be created.

4. The Director of Medical Education and Research is directed to take necessary further action accordingly. The Director of Medical Education and Research should design a transparent mechanism for selecting candidates through a well laid out process.
